REGULATIONS

ANY AMATEUR GARDENER MAY ENTER

There are no entry fees. The show is open to anyone interested in the beauty of nature and gardening. Potted plants must have been in exhibitor's possession for a minimum of 90 days. No artificial flowers are to be used in any exhibits. Each exhibitor is limited to one entry per section and a maximum of three entries. An exhibition only division is available.

GARDEN BOUQUETS must be grown by the exhibitor. Children's arrangements must be their own creation.

ENTRIES MAY BE BROUGHT IN Friday, May 14th between 5 p.m. to 7 p.m. or Saturday, May 15th between 7 a.m. to 8:30 a.m. **NO EXCEPTIONS.** Exhibits must be ready for judging by 8 a.m. on Saturday, May 15th. Exhibitors and visitors must leave the judging area while judging takes place.

EXHIBITORS will fill out an "Exhibitor's Card" for each entry. Include your Name and Address, Division and Section.

THE SHOW WILL OPEN to the public from 10 a.m. till 9 p.m. Saturday and Sunday from 10 a.m. to 4 p.m. No entry may be removed during the show on or before 4 p.m. on Sunday. **Exhibits not claimed by 4:30 p.m. on Sunday will be disposed of.**

ALL ENTRIES will be kept in good condition during the show. Reasonable care will be exercised in safeguarding entries. However, the Yucaipa Iris Festival Association cannot assume responsibility for injury or loss of any properties or materials.
