IRIS FEST CRAFT VENDOR

Please read information sheet carefully !

Submission of application & fees does not guarantee acceptance AND returning vendors must re-apply each year and are not guaranteed acceptance. We reserve the right to limit number of vendors with similar items. The sooner you return your application, the better chance that you will be included. The Yucaipa Iris Festival cannot guarantee sales. Following are some of the guidelines which will be followed:

ALL PAYMENTS, INCLUDING FOR CITY BUSINESS LICENSE, MUST BE INCLUDED WITH APPLICATION.

There will be **NO REFUNDS** due to rain or other problems causing cancellation of the event, and which are beyond the control of the Yucaipa Iris Festival Committee. Due to conflicts in scheduling of other events, there will be **NO RAIN DATE**. Also, there will be **no refunds for any reason** within 30 days of the event. (After April 20)

SPACES ARE 10 x 10. Vendors must provide their own canopies (no larger than 10 x 10), tables, etc. Each space has one 110 electric outlet. All displays must be professional-looking and present a tidy appearance at all times. Any storage containers must be stored out of public view. **Vendors may sell in their designated area only. Vendors may not approach people outside of their own booth or at the booth of another. Roving outside of your area with flyers or products is prohibited. Hand-lettered, and/or temporary looking signs are strictly prohibited.**

Booth may not be sublet or shared by different businesses. No activity or sales may be conducted other than that indicated on application. **Alcohol, smoking and pets of any kind are prohibited** in the selling area! Please leave them at home!

All Vendors must participate by being present, or having a representative present, in their booths all three days and during all hours of the event. Those not adhering to this rule will not be permitted to return.

This is a family event. Items that are offensive in nature, in poor taste, dangerous, or promote the use of drugs, alcohol, smoking or violence are strictly prohibited. Violation of this rule will cause eviction of vendor and forfeiture of fees (Examples: "Stink Bombs" and silly string). (This event will be held on grass. **Absolutely no stakes are to be driven in to the ground.** Use only weights to hold down displays and canopies in case of wind.) We recommend that your bring a dolly to assist in unloading & loading.

The City of Yucaipa requires anyone doing business within the city to possess a current Business License. An application is enclosed for **those who do not have a yearly license. Please submit, with your Craft Faire application, a separate check made out to the City of Yucaipa in the amount of \$12.50 for the Business License. The city requires non-profits to have a Business License as well, but there is no fee. Checks for the event must be made out to the Yucaipa Iris Festival.**
